<p><b>Step 1</b> Background / eligibility check. Only passport is needed. 24 hours.</p> <p><b>Step 2</b> Signing of agreements, Payment of processing fee</p>	<p><b>Step 3</b> Investment is authorized; applicant wires EUR 300,000 to the state-licensed investment fund's deposit account.</p> <p><b>Step 4</b> All investment-related documents required for the application are issued as per the Hungarian government's relevant legislation.</p>	<p><b>Step 5</b> The main applicant and all qualifying family members visit the Hungarian authorities to submit their temporary residence permit applications.</p> <p><b>Step 6</b> Authorized lawyer collects the resident permits from the Hungarian authorities (after no more than 14 days).</p>	<p><b>Step 7</b> File preparation – trip to Hungary for family PR application (no earlier than six months after receiving the temporary resident permits).</p> <p><b>Step 8</b> Collection of permanent resident cards (minimum 3 months after submitting the PR applications).</p>
